

Item 4. Appointment of Officer

At the meeting of the Board of Directors of Nickel Asia Corporation (the "Company") held on 03 May 2018, the Board approved the appointment of Mr. Michio Iwai as a Vice President of the Company effective 03 May 2018.

Mr. Michio Iwai, 67 years old, was a Vice President of Taganito Mining Corporation (TMC), a wholly-owned subsidiary of the Company, until April 2018. He began his career in Pacific Metals Co., Ltd. (PAMCO) as a Geologist in its Engineering Department in Thereafter, he served as the Deputy Treasurer of TMC, before becoming the Deputy General Manager - Mineral Resources of PAMCO. He obtained his Bachelor of Science Degree in Earth Science from Waseda University in Japan and his Master's Degree from the Science and Engineering Division of the same university.
